

Participant Release of Liability and Assumption of Risk Agreement

I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby voluntarily agree to release, indemnify, discharge, defend, and hold harmless and covenant not to sue any and all Indemnified Parties and their successors, assigns, heirs, and other representatives from any and all claims, demands, losses, expenses (including without limitation reasonable attorney's fees), actions, judgments, and suits asserted against, suffered or incurred by the Indemnified Parties at any time and any and all liability arising out of or related to any injury, disability, illness, or death I may suffer, or loss or damage to any person or property, whether arising from the negligence or any other act or omission of the Indemnified Parties or for any other reason, to the fullest extent permitted by law.
